Role Purpose

To provide, as part of the theatre team, a high standard of sterilising service consisting of the decontamination, inspection, testing, assembly, packing and sterilisation of reusable medical devices. This specifically involves reprocessing of contaminated sets of surgical instruments, accessories and other related equipment used within our operating theatres.

Clinical Practice

- Safe and appropriate handling of contaminated instruments and equipment including sorting, (for manual or mechanical cleaning) disassembly, inspection, pre-clean (if required) and appropriate loading of washer/disinfector in accordance with established procedures
- Inspects, tests and appropriately packages instruments prior to sterilisation (Wraps, pack, label, seals)
- Identifies appropriate methods of sterilisation and documents load contents
- Participates in formulating local procedures and demonstrating current, new, or revised procedures to other sterilising technicians
- Operates sterilisers and processing equipment in accordance with established procedure, verifies steriliser parameters and maintains predetermined specific levels (including both loading and unloading, coding and distribution stages)
- Responsible for critical and specific documentation i.e. recording load sheets, release criteria, and unplanned breakdown records, recall of sterile supplies,

- Maintain high skill level sterilisation techniques, aseptic techniques, and infection control
